Answers:

- 1) July 1st The Canada Day celebrations occur all across the nation.
- 2) Windsor The fireworks are a joint effort with Detroit. They are fired over the Detroit River, which separates the two nations. There were close to a million spectators in 2011.
- 3) 1867 The British North American Act is often referred to as the BNA. This act sets the general guidelines for the Canadian Government.
- 4) Manitoba The territory of Manitoba was under British rule. It was part of the land acquired in 1763.
- 5) Sir John A. MacDonald Sir John A. MacDonald was prime Minister for nineteen years. These years were not consecutive.
- 6) Trafalgar Square These events include various performances and street hockey.
- 7) The Snow Birds This elite team is officially known as the Royal Canadian Air Force's 431 Air Demonstration Squadron. The squadron received their colors on October 16th, 1999.
- 8) 1982 The change was officially made on the 27th of October, 1982.
- 9) Dominion Day In Ottawa, celebrations are held on Parliament Hill.
- 10) Queen Victoria Queen Victora signed the BNA. This proclamation set many of the guidelines for Canada's government.
- 11) 4 They were Ontario, Nova Scotia, New Brunswick and Quebec.
- 12) The Viscount Monck This actually makes him the first Governor General of Canada. Before the signing of the BNA, this position was called Governors General of the Province of Canada.
- 13) Hong Kong This event was called Canada D'eh and was celebrated on June 30.
- 14) Windsor This event is a combined effort between Windsor and its American neighbour Detroit.
- 15) Queen Elizabeth II The Queen has celebrated Canada Day in Canada on five different occasions including the 100th birthday party.
